Jackson County Health Department Flu Clinic Schedule 2008

No restrictions - open to anyone wanting flu vaccine

For those with limited mobility, curb service is available at all public clinic sites.

When you arrive at the clinic send someone in to request this service.

Fee for Flu Vaccine \$30 - Fee for Pneumonia Vaccine \$45

Part B Medicare is Accepted

Please bring your red, white and blue Medicare card and any additional insurance cards with you to the flu clinic.

The health department is not allowed to bill Medicare Advantage Insurance Plans (HMO, PPO, PFFS) for flu vaccine.

Public Aid medical card also accepted for children and adults.

Eligible State of Illinois employees and retirees with proper ID may receive flu shots paid for by the State.

Flu vaccines, including FluMist (no shot intranasal vaccine) and preservative free vaccine for \$13/dose are available for children age 6 months thru 18 years through the Vaccine for Children Program. Some restrictions apply. Please call 684-3143, ext 119 for details.
